- Ride as far to the right side of the road as practical.
- Ride single file except to pass when possible.

**Release and Waiver Statement:**

In consideration of the acceptance of my entry, I, the undersigned participant, for myself, my family members, heirs, administrators, personal representatives, successors and assigns hereby fully release, discharge and hold harmless Rocky Mountain Events Inc., EMG, Douglas County, the Town of Castle Rock, any sponsors, owners and operators of motor vehicles and officers, directors, employees, volunteers and lessors of any of the foregoing persons or entities from any and all liability, whether resulting from negligence of any aspect of the Elephant Rock
